

## REQUIREMENTS TO PREPARING CAMERA READY PAPERS

Materials may be submitted in Ukrainian, Russian or English. Text of the report must be in Microsoft Word 97/2000/XP/2003.

Papers to be sent:

**1. Text of the report** (4 full pages) is to be submitted in doc-file, together with hard paper copy printed on one side of A4. It should include: brief abstract of the issue under consideration including the urgency of the unsolved tasks with references; formulation of task to be considered; characteristics of method for solution; results obtained; conclusions; list of references. Text of the report must include the original solution to the specific ecological problem.

• Margins – 2,3 sm., page – A4, book.

Times New Roman Cyr, 11 pt, single line spacing.

Formula: 11 (Σ-12, table. - 9pt), subscript/superscript - 8pt (Σ-11, table - 7pt), sub-subscript/ superscript - 6pt (Σ-8, table. - 5pt), symbol - 10 pt. Placed centered.

Illustrations are to be copied in buffer, choose “Correcting”, “Special insert ” then select “ Image”; inscription 9 pt: fig. 1a; fig. 2a, б. Placed centered.

• Paper arrangements:

UDC code shall be printed on the upper left line, 11pt;

Authors: Omitting one line, print names of coauthors, country, city ( in parentheses); bold (12pt);

Title of the report: Omitting one line, print paper title in the middle of the next line in bold capital letters, 12pt, interval 6pt;

Text of the report: omit one line and begin from the paragraph, 11pt;

at the end of the report – print initials and surnames of each author, scientific status, place of work, phone, email, ICQ or Skype each author;

Abstracts in three languages (Ukrainian, Russian or English) up to 76 words, including title and authors names , 5-7 key words, UDC code.

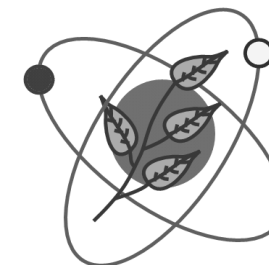
